ANNUAL SIGN PERMIT INFORMATION

The Town of Bartlett Zoning Ordinance in Article XVI Signs Section E-6 provides for the use of on-premise temporary signs for real estate or contracted services. An annual permit must be obtained that runs from January 1-December 31 of each year. The annual permit fee is \$10.00 and it is the responsibility of the business to renew its permit each year. Failure to obtain an annual permit may result in the issuance of a Land Use Citation which involves a court appearance and possible fines.

The annual permit covers the standard small real estate sign or contractor service sign normally displayed at residential properties. Signs may <u>not</u> be displayed in the road right-of-way nor affixed to trees. The sign must be removed no later than 15 days after a real estate closing or the completion of the contracted work. Failure to comply with this requirement will result in the revocation of said permit.

The annual sign permit **DOES NOT** cover:

- 1) Larger real estate or contractor signs normally used in the commercial zones. A separate sign permit must be submitted for these and they do count in the allowable sign area on the property.
- 2) Open Houses a separate permit must be obtained for these. They can occur no more than three times annually per property, are three days or less in duration, and can be off-premise signs that are no more than 4 sq. ft. in size.
