 - > It is always sensible to have a vision. I commend you for being proactive and for looking toward the future needs of our town, Bartlett.
 - \triangleright Sounds like the vision of the rich well-to-do and not anyone who struggles to live in a service industry area where you are treated as 2^{nd} class by out-of-staters and their views.

The following comments on the recommendations, or suggestions for other recommendations, were made:

- The village does not need to be commercialized. Plenty of area in rest of town for commercial uses. Leave the village a residential village.
- Snowmobiling on railroad! and other. We have plenty of x-c ski trails.
- Many of the idea, suggestions use the word "consider." Does considering an idea cost money? Who will do the considering? Volunteers, selectmen, a cooperative effort or group. If a group considers an idea, what chances are there that the consideration might become _____ (fill in the blank) true, valid, completed, built, law.
- I feel this survey should carry very little weight in planning Bartlett's future. There should be some way to prove participants are actually Bartlett residents and that multiple surveys aren't being filled by one person. Though you might get some sort of insight, it could easily be misleading. Consider a new survey that is not so vague and more credible.
- Zoning is for Flatheads. They moved here and brought their ways with them. You no longer own your property. Everyone else has more say on what you do than the owner. More socialists, maybe they need to live in Russia?
- Debbie and I are full time residents of Glen since October 17, 2012. We <u>love</u> it here! I didn't see a need to complete the survey with the feeling that, "Don't fix it if it ain't broke!" Just one thing: Can anything be done about the motorcycles that come thundering up and down the Glen Ledge Road and through town? Thank you.
- Recognize snowmobiling as a recreational use.

- Would it be possible to have/build sidewalks in Bartlett Village to make our village more family/pedestrian friendly? Apply for grants for safe walking communities? Is it possible to post "Please do not use Jake brakes" signs in Bartlett Village? Would the Recreation Department consider trying to bring in a farmer's market? Offer more adult activities (sports).
- I support the snowmobile industry in our town as it's a vibrant economic force in our community, but only
 support expansion within the zones they are already operating. The town should limit road crossings within
 and expansion and make sure the needs of non-motorized recreation are considered and incorporated into
 any decision to expand.
- Develop snowmobiling trails.
- We wish we had more time to review the master plan because it is an extremely valuable document. So our first comment is "please begin emailing us when something of this magnitude is ready for perusal". The web site should be a source of information that is viewed often – and should include links to all community groups, such as the Friends of the Bartlett Library and the library itself. All committee meetings should be posted ASAP. We should be sent an email for all information – then it is up to us to decide whether to read it or not. I receive emails from Jackson all the time and find some of the information valuable – I wish we had the same accessibility for Bartlett. On page 6 The Kearsarge Peg Mill should have a notation regarding it's destruction. It is a shame restoration could not have been made before that happened, but I suppose it was private property and nothing could be done. To have the only Peg Mill in the country could have been of value. We are hopeful the Town of Bartlett will encourage more "industrial" uses and very glad Bart's Deli and Cabin Fever seem to be prospering. Perhaps sidewalks in the center town would encourage more walking (safely) and more business considerations. The parks in the center of town are wonderful (and the new park/parking lot at the Bartlett Congregational Church should have been mentioned in the report), but the hazards of walking anywhere within the center of town might detract from enticing business to consider moving here. Volunteer needs were mentioned often and we believe the MWV Garden Club should have been mentioned because of all the work they do for the village center = Wills Park in JBES, the flagpole in the center and in front of the monument at Hodgkins Park. The radical improvements at the Bartlett Congregational Church park/parking should have been acknowledged as well. Wills and BCC made a huge difference in the center of Bartlett and only Gazebo Park was mentioned. Having only 8.3% of the town zoned for Commercial/Industrial does not leave many opportunities to grow. We would recommend the Roundhouse be given attention before the same thing happens to it (or it falls down). I am hopeful the Catholic Church will be approved at the meeting today and the town will support the BHS as they strive to restore and provide Bartlett History in a distinctive way. We were surprised the Morrell Property was not mentioned by name and there were several mentions of building bike paths, etc. It was even mentioned that property should be purchased for this purpose. I'm sure the bike paths will take more purchases, but the Morrell Property was donated years ago and the Recreation Department is currently working diligently to see a beginning soon. A focus on that should be in the next 5 year plan and the bike paths should be a consideration, but not the main focus. Walking paths, fields, exercise paths, should be designed and supported during the next 5 years – building off of that in a future plan. We would support considering a bypass if Route 302 ever became 4 lanes or expanded out, so this is something to consider regarding all new improvements when improvement such as the Morrell Property begin to take shape. It is unfortunate the Cook property that was a large flat parcel with access to the Saco River was not purchases by the town. We now have another unsightly business with a trailer near the center of town and were surprised to hear how low the price selling was. An opportunity lost. We were also surprised to see that JBES owns 30 acres of land and next to Saco River beach property there is nothing listed. Is the property JBES sits on actually 30 acres? We agree roads (and bridges?) need to be maintained but didn't see that mentioned as a priority. Discussion whether private roads should be taken over by Bartlett would appear to be a private issue between the town and homes affected. We are completely dependent on Time-Warner and have difficulty receiving cell phone calls so would like consideration given to upgrading communications infrastructure. The lack of any visible towers is admirable but somehow there should be upgrades for better access. It is the world we live in. If we had more time, we could have organized this better, but tried to touch as many bases as possible. This is the first time we noticed having the opportunity to provide input and it is appreciated just wish we had been notified earlier. Also would have liked the names and email addresses of the planning board so we could email each of you, hoping you'd have time to look this over before tonight's meeting.
