## Town of Bartlett Office of Selectmen Meeting Minutes Wednesday, December 9, 2020 Meeting via Zoom

Attendees: Chairman Gene Chandler, Selectman Vicki Garland, Selectman August Vincent

Meeting opened at 2:31 p.m.

Chairman Chandler attended the meeting in person. Selectman Garland and Selectman Vincent attended via Zoom.

Selectman Garland and Selectman Vincent came to Town Hall on Tuesday 12/8/2020 to sign checks, letters and building permits. Chairman Chandler signed items throughout the meeting.

Chairman Chandler reported that the minutes need to reflect the board's agreement on donating the utility truck/old ambulance from the Bartlett Fire Department to the Career Tech Center at Kennett High School in Conway, NH. All selectman agree to the donation.

Chairman Chandler inquired as to the availability of Selectman Garland and Selectman Vincent for a Bartlett Jackson Ambulance committee meeting. Selectman Garland would prefer not at noon on Wednesday or Thursday due to a previous commitment. Selectman Vincent would prefer a meeting near the current board meeting time. This information will be reported to the Jackson Selectboard.

AA Lynn Jones reported that budgets and narratives have been requested from all department heads by 12/28/2020. AA Jones also reported that Secretary Mary Miller has prepared a list of current town fees for the board to review.

AA Jones asked if the board had a response to the request to have a warrant article for broadband committee. Chairman Chandler reported that they did not have a response yet.

Chairman Chandler asked if there were any other items.

Kevin McEnaney joined the meeting and asked about an email he had sent earlier in the day. Chairman Chandler reported that the town is awaiting guidance from the Secretary of State and the Governor regarding guidelines for Town Meetings and Voting. The only decision made to date is that voting will take place in some manner at the Fire Station in Glen. Moderator Head will be attending a meeting discussing the process today.

Kevin McEnaney expressed concerns over meetings not having additional cameras so that all members could be seen. Discussion about the requirements of being seen was had. Chairman Chandler reported that even with cameras he would not be willing to be filmed for the Zoom meetings and he discussed it with Selectman Vincent who agreed with him. Selectman Garland expressed her concerns of having her image on the internet.

Discussion by unidentified attendees was had regarding SB2 meetings, traditional town meetings and hybrid versions. Chairman Chandler and Selectman Garland expressed concern about giving up the traditional town meeting format.

There being no further business the meeting was adjourned at 2:53 p.m.
