

Town of Bartlett Office of Selectmen

Meeting Minutes: November 2, 2012

Attendance: Chairman Gene Chandler, Douglas Garland, David Patch

Meeting opened at 08:30 AM.

Police Chief Timothy Connifey telephoned the Selectmen to let them know that he is having some radio issues and is having Ossipee Mountain Electronics look at them. He also mentioned to the Selectmen that he is in the process of getting the winter tires put on the cruisers.

Chairman Chandler made a motion at 09:10 AM to enter nonpublic session to discuss a request for aid under NH RSA 91-A: 3 II (c). Selectman Patch seconded the motion. Motion carried unanimously. Selectman Garland made a motion at 09:30 AM to end the nonpublic session and to seal the minutes. Chairman Chandler seconded the motion. Motion carried unanimously.

Erik Corbett stopped by and let Lynn Jones, AA, know that he is in charge of picking up the democratic signs after the election is over and requested that we let him know if he misses any of them. Corbett left contact numbers where he could be reached.

David Patch made a motion at 09:45 AM to enter nonpublic session to discuss a request for aid under NH RSA 91-A: 3 II (c). Selectman Garland seconded the motion. Motion carried unanimously. Chairman Chandler made a motion to end the nonpublic session and to seal the minutes. Selectman Garland seconded the motion. Motion carried unanimously.

Arthur Heigl of 25 Acorn Lane (1DNDRD-52-R00) met with the Selectmen in reference to the local cable company as he wanted to review the agreement that the town has with the company. Heigl stated that he had received notification that they are adding \$4.00 to his bill each month for a modem that he has had forever. They are also moving some of the original basic channels to be part of their package deals so that if you still want those channels you have to pay extra. Lynn Jones, AA, gave Heigl a copy of the town agreement. Chairman Chandler stated that the problem is that they are the only game in town. Heigl replied that is not entirely true as there are others that are available. Chairman Chandler commented that we are stuck and if you can find someone else that we would be happy to look at a competitive product. Heigl replied that this is upsetting. Selectman Garland mentioned that a lot of people are upset as they are raising the rates but reducing the service. Chairman Chandler stated that we share in Heigl's frustration and if he finds anyone to compete to please let us know.
