

Town of Bartlett Office of Selectmen
Meeting Minutes: September 6, 2013
Attendance: Chairman Gene Chandler, Douglas Garland, David Patch

Meeting opened at 08:30 AM.

Chairman Chandler requested that Bartlett Jackson Transfer Station manager, Jon Edgerly, provide a report on recycling which details the costs as well as income received.

Police Chief, Timothy Connifey, dropped off a fire works display application for Attitash Ski Area for the Selectmen to review.

Steven Dean, owner of Good Harvest Inn (1RT016-118-L00) stopped by in reference to the letter he had received from the Selectmen concerning whether his septic system could hold the proposed use for the remodeling of the motel units. There had been a septic system designed in 2001 but it had never been installed and per the State regulations he has to comply due to the commercial nature of his project. He also has to provide documentation that the system can support the proposed changes. Dean stated that the proposed changes he is doing is a reduction in the number of units and therefore should be a reduction in the amount of waste so he doesn't believe that the septic should be an issue. Chairman Chandler stated that the State gets excited when changes are being made and they like to make a bad system better and therefore, he needs to contact, the local State inspector, Rick Treiss, and talk to him. Dean commented that it wasn't an issue last time and doesn't understand why it is now. Selectman Garland explained that he needs to confirm that there will be fewer gallons. Lynn Jones, AA, mentioned that changes are being made all the time to the State regulations and therefore she believes that all he needs to do is have a system designed, not installed but he should check with Rick Treiss. There is a different director at the State and each director has different ideas. Dean commented that he hadn't thought it was an issue because he had received a previous permit that expired and he was just trying to renew it. Chairman Chandler apologized that this probably should have been mentioned before and advised him to call State Inspector, Rick Treiss, and he would probably need to get a design done. Dean also inquired as to how much the fee would be for the three permits. Lynn Jones, AA, explained that each permit is considered a new permit and the fee would be \$25.00 per permit for a total of \$75.00. Dean also mentioned that he has been in contact with the Lower Bartlett Water Precinct to obtain the necessary permits from them since he is located in the precinct.
